- Every aspect of our personal lives is up for regulation and control, and is benchmarked against open-ended "sustainability" goals

Whence Sustainable Development?

British economist, Barbara Ward's 1966 book "Spaceship Earth" advocated for sustainable development and a new international economic order linking the global environment and social justice

As political doctrine, "Sustainability" was introduced by the 1987 "Our Common Future" report of the United Nations World Commission on Environment and Development, authored by Gro Harlem Bruntland, VP of the World Socialist Party





The U.N. Global Plan To Implement Sustainable Development


- The United Nation's one-world plan for the 21ST Century, brokered at the 1992 U.N.'s *Earth* Summit in Rio de Janeiro, Brazil

- Redistribution of wealth takes the place of individual success based on individual effort
- Equality of outcome replaces equality of opportunity
- National/sovereign boarders are unjust
- Ownership of private property is unjust

Economic Prosperity


- Agenda 21 relies on Public /Private Partnerships to achieve its vision of economic prosperity
- Open-market competition is to be replaced by a centralized, state-regulated market of favored corporations... known as "corporatism"
- Favored corporations/stakeholders get special tax treatments, legislation that guarantees profits, preferential land use, and protection from other competitors... "corporate cronyism" or "fascism" are other descriptive terms

Ecological Integrity

- Environmental protection, biodiversity, endangered species, climate change
- Humans are deemed to be just one of coequal biological entities on Earth, and must sacrifice to save the planet
- One example: Land zoning legislation designed to herd the public into high-density development areas on regulated transportation corrodors



- U.S. President George H. W. Bush signed the document on behalf of the U.S. in 1992
- A "soft treaty" not ratified by the U.S. Senate
- U.S. President Bill Clinton created the "President's Council on Sustainable Development" in 1993 bringing the goals of the U.N. Agenda 21 into our Federal government

- ICLEI (International Council for Local Environmental Initiatives) is an eco-activist organization promoting the regulation of energy use and greenhouse gas emissions, via climate sustainability plans, and climate action and energy plans
- Founded in 1990, ICLEI renamed itself *Local Governments for Sustainability* in 2003



Introduction



The Thomas Jefferson Planning District Commission (TJPDC) was one of 45 awardees across the country selected for HUD's a Regional Planning Grant out of 225 submissions. As the lead applicant, TJPDC represented the Charlottesville-Albemarle Metropolitan Planning Organization (MPO), major partners including the City of Charlottesville and Albemarle County, and the University of Virginia as a consulting partner, and other partners: the Jefferson Area Board for Aging (JABA), Thomas Jefferson Partnership for Economic Development (TJPED), Rivanna River Basin Commission (RRBC), and the Local Energy Alliance Program (LEAP).

The project set out to develop a Livability Implementation Plan for the Charlottesville-Albemarle MPO Area. The process to develop this plan, referred to as the Livable Communities Planning Project (Livability Project), builds upon the region's 1998 Sustainability Accords and other area planning documents to integrate cross-cutting strategies for land use, transportation, housing, economic vitality, air and water quality, and energy use. The Livability Project was launched in April 2011 in conjunction with the kick off to the Charlottesville & Albemarle County Comprehensive Plan and Long Range Transportation Plan updates. A project summary is available here.

The Livability Implementation Plan contains five major project deliverables which are described in more detail below.


The Illusion of "Public Consensus"

Regional Planning Subsumes Local Government




California Leading The Way




Figure 2 — Household electricity demand profile recorded on a 1-minute time base

Quinn comments on the implications of such data mapping capabilities

...the massive deployment of smart meters across the country and the trend toward finer and finer interval data means that more and more information will be discernable about more and more people. While the raw information about when an appliance event occurred in a given home may not seem to be sensitive information, it could be used to construct a detailed picture of residential life. Tracking appliance events means smart grid information could tell you the answer to questions like

- How often does a given customer eat microwave dinners as opposed to cooking three-pot meals?
- How many hours of TV does a resident watch? What kind of TV is it?
- When does a resident normally shower (and so cue an electricity draw from the water heater)? (Quinn, 2009, p 9)



Real Costs of Sustainability Any Benefits?


