



## From Senate Report: Millions In Funding Albemarle Taxpayers Tapped For \$13, 500 Request

"Virginia Organizing is remarkable because the supposedly humble grassroots group receives millions in donations from major foundations - primarily the Marisla Foundation, which gave nearly \$1.3 million from 2010 to 2012 and Sea Change, which donated \$600,000 in 2010 and 2011...They have also received hefty funding from the Tides Foundation, the Rockefeller Family Fund, the Park Foundation, as well as others. Additionally, they have established more than two dozen fiscal sponsorships, which they dub "partners" on their website and filings... (including the local *Environmental Health News*)

Accordingly, a group that represents itself as a small community based organization is actually led by significant power brokers in the far-left environmental community and is heavily funded by the Billionaire's Club."
